<b>Specific Action Recommendations for Board to Consider:</b>			
The Endowment Fund Committee met to review the Committee Guidelines, Investment Policy for TSSRM, the financial statements for 2008, and the financial statements for January and February 2009.			
<b>Upon review of the 2008 and 2009 financial statements, the Endowment Fund Committee noted the following:</b>			
<ul style="list-style-type: none"> <li>Under the Bank Fee Headings the following example narrative occurred on each statement with varying dollar amounts and dates, "1/10/08 FINANCIAL MGMT SERVICES FEE COLLECTED BASED ON A MARKET VALUE OF \$171,161.45 (AMOUNT POSTED TO PRINCIPAL CASH)". The total portfolio market value for the Endowment Fund Committee for this month was \$46,092.36. Robert Moen dispelled our concern that the Endowment Fund was supporting the management fee cost of this fund and other funds such as the scholarship fund. Each management fee is prorated and posted to the appropriate fund. The Endowment Fund had \$487.91 posted with management fees for 2008, and has \$66.29 in management fees for 2009. It is the committees concern the Texas Section SRM is paying a management fee to Frost Bank for transactions which deal with mutual funds and bond funds which usually contain management fees within the funds. Many of these mutual fund groups such as PIMCO etc contain various funds within the group that range from very conservative bond funds to aggressive growth funds. Once in a group, assets can shift from one investment strategy to another with no management fees or commissions. <b>If the management fee of \$487.01 for the endowment fund's \$46,092.36 is extrapolated to the total amount of Texas Section SRM's total portfolio of \$171,161.45, Texas Section SRM paid Frost Bank \$1,811.83 in 2008 in management fees.</b></li> <li>Asset Allocation for the Equity investments and Fixed income investments adhered strictly to the TSSRM Investment Policy for the Endowment Fund. Allocation primarily centered within the guideline ranges with some movement towards Fixed income investments towards the end of 2008. Money market funds exceeded the guideline of 10% for ten of the months reporting, but never exceeded 11.7% which is totally acceptable.</li> <li>Total transactions for the 2008 year numbered in 18 Sales and 18 Purchases of Equity and Bond Funds. These</li> </ul>			

did not include transactions of dividends, capital gains distributions, or money market fund. Three Buys and 3 Sales for 2009 have occurred.

The transactions were for the following volumes of shares occurred:

2008 SALES - 17.695, 14.498, 4.161, 3.94, 15.136, 42.284, 12.594, 0.385, 21.975, 37.338, 5.808, 90.251,  
144.357, 38.362, 62.244, 27.937, 27.193 (17 Transactions)

2008 PURCHASES - 8.025, 63.55, 11.256, 64.206, 153.527, 578.485, 57.29, 25.414, 54.714, 52.05, 17.701,  
9.726, 138.915, 220.298 (14 Transactions)

2009 SALES - 209.57, 25.486, 153.917 (3 Transactions)

2009 PURCHASES - 13.411, 22.252, 30.934, 66.248, 106.609 (5 Transactions)

Transactions for the past 14 months for each of the various funds consisted of sales only, buys only, sales and buys, buys and sales of 6 funds, and two funds which were bought and sold three months later twice during this period. It is the committee's concern that the accounts are showing unnecessary activity for such stable funds in order to justify the management fee. The Portfolio Asset Allocation does not indicate that the small transactions of share lots were needed to adjust the portfolio to remain within TSSRM's guidelines.

**The Endowment Fund Committee requests that the Board of Directors for TSSRM consider the Committee's recommendation that the Endowment Fund be moved to a major Investment Brokerage Firm of their choosing such as Edward D. Jones so that financial management fees be reduced or eliminated.** The portfolios can be transferred at no cost from Frost Bank to another firm. The only fees that will arise will be sales charges on the new Group funds plus ongoing management fees for individual funds. As investment strategies change through the years, these Group funds will have individual bond or mutual funds to accommodate changes in investment strategy and will allow movement with no additional sales charges.

#### **Summary of Work During Period:**

Dan Caudle reported that the Endowment Fund began the year on January 1, 2008 with a total portfolio balance of **\$47,852.87** with no contributions or donations to the Endowment as of December 16, 2008. The portfolio balance as of November 30, 2008 was **\$36,852.17**. This represented a net loss of **\$11,000.70** or **23%** of the overall value of the Endowment Fund through that last reporting period. The bond funds suffered at that time a **6.1%** loss from purchase price while the equity funds suffered a **32.2%** loss from purchase price. During the month of December 2008 the total portfolio fell to **\$36,743.72** representing a loss of **\$108.45** of the overall value of the portfolio. The bond funds suffered an additional loss of **0.8%** loss from purchase price while the equity funds also suffered an additional **0.8%** loss.

The Endowment Fund began the year on January 1, 2009 with a total portfolio balance of **\$36,743.72**. There have been no contributions or donations to the Endowment as of December 16, 2008. The portfolio balance as of February 28, 2009 was **\$34,197.37**. This represents a net loss of **\$2,546.35** or **6.9%** of the overall value of the Endowment Fund portfolio for the first two months this year and includes a **\$313.74** withdrawal paid to the Texas Section SRM. The bond funds sank to a level of **7.1%** from purchase price while the equity funds sank to level of **40.6%** loss from purchase price.

**Specific Action Recommendations for Board to Consider:**

I recommend that the TSSRM Board of Directors review the committee guidelines for the Resolutions Committee to consider the required membership of the committee. Currently the TSSRM Administrative Handbook states that all Past Presidents who are current members of TSSRM are members of the Resolutions Committee. Using those guidelines, there are currently 32 Past Presidents who are still members of TSSRM. That is entirely too many people to be on a committee. It is an impractical and unmanageable number. The current list of Past presidents who are members of TSSRM:

- *Jerry Payne, Paul Loeffler, Charles Anderson, Bob Knight, Charlie Hart, Jenny Pluhar, Bob Whitson, Larry White, Wayne Hanselka, Tim Fulbright, Lynn Drawe, Barron Rector, Dan Caudle, Allan McGinty, Butch Taylor, Darrell Ueckert, Fred Bryant, Steve Hartmann, Harold Schmidt, Ron Sosebee, Mark Moseley, Pat Reardon, Russ Pettit, Rhett Johnson, Wayne Hamilton, Chip Merrill, Bruce Foster, Joe Norris, Bob Ragsdale, Joe Schuster, Ben Sims, and Rudy Pederson.*

Many of the past presidents who are no longer active in TSSRM even though they are still members. I recommend that the committee membership guidelines for the Resolutions Committee be revised to state that the committee will consist of no more than 12 members. The membership should be made up of a Chair and Chair-Elect, and the 10 additional most recent Past Presidents who are current members of TSSRM. The Chair and Chair-Elect could be selected from among the entire group of Past Presidents and would not be limited to being among the most recent 10 to 12.

**Summary of Work During Period:**

The Resolutions Committee received one informal recommendation that TSSRM consider electronic voting for issues that require voting by the general membership. The recommendation was similar to recommendations that have been made in the past. Darrell Ueckert conducted a thorough review of the pros and cons of electronic voting in 2007 at the request of President Paul Loeffler. His conclusion was that he did not recommend electronic voting at the section level for a variety of reasons.

The proposal was sent electronically to the members of the Resolutions Committee for their consideration and input. I received responses from 10 members of the Resolutions Committee. The result was 9 opposed to electronic voting and 1 in favor. I shared these comments with the person who submitted the recommendation, and he withdrew his proposal.

No other proposals or resolutions have been received by the Resolutions Committee as of this date.

## Tree count places Texas No. 2 in forestland

AUSTIN — The first detailed statewide tree count in Texas history is headed toward this conclusion: Texas is No. 2.

The Texas Forest Service said Wednesday that initial results of the first inventory outside East Texas indicate that the state has 60 million acres of forestland. That ranks second to Alaska and represents about 23 percent of the forestation in the southern United States.

State foresters have counted trees in the Piney Woods since the 1930s. But this was the first scientific statewide tally.

"Last one we had was some dude on a horse in, like, 1904 rode through there and made notes," said Burl Carraway of the Texas Forest Service.

The 10-year study is at the halfway point. But Tom Boggus, the state forester and interim director of the forest service, said he doesn't expect the number to change. The projection was made from 10,000 plots of land scattered from the heavily wooded areas of East Texas to the plains of West Texas.

The forest service called the report a base line for all change — like the U.S. census, but for trees.

"Before, we didn't know. We would just do a track at a time and hope we're effective," Boggus said.

"But now, we can go back and say, 'Yeah, we have made a real impact on the " mesquite control, or juniper control, or water quality.'

The report says 35 percent of Texas forests are mesquite woodlands, 25 percent are hardwood and 18 percent are juniper, also known as cedar.

Boggus said the ongoing inventory helped the forest service measure damage from the hurricanes that hit the Gulf Coast in recent years.

The forest census could also help state and private landowners evaluate the potential for biomass and alternative energy use, wildfire risk and wildlife, Boggus said.

Another 10-year survey will begin after the current one ends in 2014.
